

Sub.: Consolidated Scrutinizer's Report for passing of Resolutions through Remote E-Voting Process and on voting by Poll at 31stAnnual General Meeting held on 28 September,2015

I, Ashish Kumar Gaggar, Company Secretary in Practice was appointed as Scrutinizer by the Board of Directors of the Company for the purpose of Scrutinizing the remote e-voting process and ballot voting (Poll) carried out by the company pursuant to Section 108 of the Companies Act, 2013 read with Rule 20of the Companies (Management and Administration) Rules, 2014 for passing of the Resolutions as mentioned under item numbers 1 to 6as set out in the Notice of 31st Annual General Meeting (AGM) of the shareholders of the Company dated August 31, 2015.

- 1. The management of the Company is responsible to ensure the compliances with the requirements of the Companies Act, 2013 and Rules relating to remote e-voting and polling papers on the resolutions contained in the notice of AGM of the members of the Company. My responsibility as a Scrutinizer for the remote e-voting process and voting through ballot process conducted at the AGM is restricted to make a Consolidated Scrutinizer's Report of the votes cast 'in favour' or 'against' the resolutions stated in the said Notice, based on the reports generated from the e-voting system provided by CDSL, the agency engaged by the company to provide remote e-voting facility for e-voting and poll conducted at the AGM.
- 2. The Notice dated August31, 2015 along with Statement setting out material facts under Section 102 of the Act was dispatched to the Shareholders through courier post on Thursday, September 3, 2015 and through e-mail to shareholders whose email IDs are registered with the Company/Depository Participant(s) on Thursday, September 3, 2015. The said notice was dispatched on the basis of Register of Members made available by the Registrar & Share Transfer Agent of the Company and the list of beneficial owners made available by the depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as on Friday, August 28, 2015.
- 3. As per the provisions of Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company has published advertisement about having sent the notice of meeting and





- providing e-voting facility in Business Standard (English Daily) and Nava Telangana (Telugu Daily) onSaturday, September 5, 2015.
- 4. In terms of the aforesaid Notice, voting through electronic means was kept open for 3 (Three) days from Friday, September25, 2015 (9:00 A.M.) to Sunday, September27, 2015 (5:00 P.M.).
- The voting rights of members were considered in proportion to their shares in the paid up equity share capital of the Company as on the cut-off date i.e. Monday, September, 21, 2015.
- After the time fixed for closing of the poll by the Chairman, one ballot box kept for polling were a locked in my presence and the members who were present.
- 7. The locked ballot boxwas subsequently opened in my presence and in the presence of two witness and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Company / Registrar and Transfer Agents of the Company and the authorizations / proxies lodged with the Company.
- 8. As required under the said rules, after the closure of the voting at the Annual General Meeting, the votes cast through poll were counted, thereafter the votes cast under remote c-voting facility were unblocked in the presence of Mr. Anil C and Ms. Neha P who are not in employment with the Company. They have signed below in confirmation of the votes being unblocked in their presence.






